Conditions

Conditions

1. The licence shall be displayed in the prominent place in the premises for which the licence is being issued and shall be produced for inspection as and when required by an Insecticide Inspector ,licensing officer or any other officer authorized by the Government in this regard.

- 2. Any change in the name of the expert staff, named in the licence, shall forthwith be reported to the licensing officer.
- 3. The licensee shall scrupulously comply with each and every condition registration of the insecticide(s), failing which the licence is liable to be cancelled.
- 4. No insecticide shall be sold or exhibited for sale or distributed except in packages approved by the Registration Committee from time to time.
- 5. The licensee shall comply with the provisions of the Insecticides Act.1968, and the rules made thereunder for the time being in force.
- 6. If the licensee wants to sell, stock or exhibit for sale or distribute any additional insecticide, he may apply to the licensing officer for addition in the licence for each such insecticide on payment of the prescribed fee.
- 7. The licensee shall maintain the record of 'date expired Insecticides' separately in the format as per Appendix A.
- 8. The licensee shall maintain the record of sale/distribution of Insecticides in the format as per Appendix B and shall submit monthly return to the Licensing officer. All the registers are to be kept under secure custody by the licensee and shall be provided for scrutiny any time to the Insecticide Inspector, Licensing Officer or any other officer authorized by the Central Government and/or the state Government.
- 9. Any other condition(s) as specified by the Licensing Officer.
